1	Opening words by Forum President
<p>PDG Nebojsa Davidovski welcomed International President Gudrun Bjort Yngvadottir, PIP Eberahd Wirfs, PIP Giuseppe Grimaldi, PIP Frank Moore, the authorized delegates, PIDs, CCs, DGs, international officers and all attending Lions to this first meeting of the European Council and declared at 17.03 the European Council 2018 as opened and gave the leading of the meeting to the general secretary PDG Zvonimir Cvetanovski.</p>	
2	Attendance and Rules Presentation
<p>Forum General Secretary PDG Zvonimir Cvetanovski called the meeting to order. After some inscription work and first clarifications about the rules applying to the European Council meetings 2018, he stated that 29 authorized delegates are present (after the vote about agenda item 4; one more delegate arrived and the work continued with 30 authorized delegates). In accordance with the Rules of Procedures, article V, 5.2, PDG Zvonimir Cvetanovski declared the quorum as being reached. PDG Zvonimir Cvetanovski pointed out the most important rules applying to the European Council meetings 2018 which have been sent to each delegation beforehand and explained that the voting and election material was distributed by Forum General Secretary, General Secretariat members and volunteers. Hence, PDG Zvonimir Cvetanovski pointed out that the supporting of the voting committee is organized. He declared putting in use the time keeping watch and reminded the speakers about time limitations.</p> <p>The rules applying to the European Council meetings 2018 are adopted unanimously by the delegations representatives.</p>

<p>The minutes of the European Council 2017 meeting in Montreux were presented by the President of Europa Forum 2017, PID Robert Rettby. They have been sent in advance to the delegations.</p> <p>The minutes of the European Council 2017 meeting in Montreux are approved unanimously by the 29 authorized delegates.</p>

<p>Forum Accountant PCC Peter Brandenburg presented final results of Europa Forum 2017 in Montreux. They are positive.</p> <p>The 29 authorized representatives approve unanimously the report of the Europa Forum 2016.</p>	
5	Presentation of Resolution 1: MD 105 Resolution about the changes of Europa Forum Rules of Procedure
<p>On behalf of MD 105, PID Phil Nathan presented the resolution which was sent ahead of the Europa Forum to the delegations.</p>

<p>MD 105 British Isles and MD 111 Germany submitted resolutions with very similar content. Therefore the two resolutions have been merged together in agreement of MD 105 and MD 111.</p> <p>On behalf of MD 105 and MD 111, PID Phil Nathan presented the resolution which was sent ahead of the Europa Forum to the delegations.</p>	
7	Presentation of Resolution 3: MD 111 Resolution about the Rules of Procedure for the Euro-Africa Committee
<p>This resolution was presented together with a very similar resolution of MD 105 in previous item 6 of the Agenda.</p>	
8	Presentation of Resolution 4: SD 126 Croatia Candidacy for hosting of Lions Europe Europa Forum in Croatia in the year 2021
<p>On behalf of SD 126 Croatia, PDG Drazen Melcic presented the resolution which was sent ahead of the Europa Forum to the delegations.</p>	
9	Presentation of Resolution 5: Application of the Republic of Serbia to become a member Country of Europa Forum
<p>Undistrict Serbia submitted the resolution which was sent ahead of the Europa Forum to the delegations to be accepted as member country of the Europa Forum.</p>	
10	Presentation of Emergency Resolution 6: Long Range Planning Committee Europe about LRPCE to have responsibility of the suggested International Director candidate rotation list for Europe
<p>Long Range Planning Committee Europe submitted emergency resolution to have responsibility of the suggested International Director candidate rotation list for Europe and that responsibility to be included under Appendix I.</p> <p>On behalf of LRPCE, PID Phil Nathan presented this emergency resolution: For Transparency: The Long Range Planning Committee Europe to have responsibility of the suggested International Director candidate rotation list for Europe. Any changes to the accepted list should first be requested to the LRPCE via the Europa Forum Archivist & Advisor.</p> <p>The authorized representatives unanimously accepted to vote about this agenda item on the European Council meeting II.</p>	

11	<p align="center">Presentation of Emergency Resolution 7:</p> <p>Long Range Planning Committee Europe about no extra cost burden to the host country</p>
	<p>Long Range Planning Committee Europe submitted emergency resolution that there will be no extra cost burden to the host country and that will follow on from Article V1 6.7 last paragraph.</p> <p>On behalf of LRPCE, PID Phil Nathan presented this emergency resolution: There will be no extra cost burden to the host country. Europa Forum is a Non-political gathering of European Lions and global Lion friends. Respect for this intention is requested from all candidates seeking elected office. The use of posters, signs, banners and similar campaign material shall not be permitted.</p> <p>The authorized representatives unanimously accepted to vote about this agenda item on the European Council meeting II.</p>

Forum President Nebojsa Davidovski adjourned the European Council meeting at 18.28.
