# Draft Resolution submitted by the Long Range Planning Committee Europe to the European Council at the Europa Forum Klagenfurt 2023

### Subject:

Revision and complete overhaul of the Europa Forum Rules of Procedure, entering into force of the revised Document.

### **Explanation:**

The Long Range Planning Committee Europe submits a draft Resolution to the European Council to adopt a new Europa Forum Manual composed of the Constitution, By-Laws, Standing Orders and their Appendices, The History of the Europa Forum, the Years of Europa Forum and the History an Contents of the Manual (previously Rules of Procedure).

The Long Range Planning Committee Europe set up a Task Force for the revison and complete overhaul of the Rules of Procedure and its Appendices in order to suppress duplicities, create more simple/reader friendly rules, to suggest a logical comprehensive structure and use a proper Lions Language understandable even to the grass root Lions.

The Task Force was composed of representatives of all the 8 Lions Europe-Areas and worked in 3 sub-groups:

- Legal (wording and texts)
- Financial (all finance related aspects of Europa Forum)
- Contents

- 3. As these are not new documents, but with some minor exceptions, the remake and rearrangement of the existing Rules of Procedure, it is proposed that the new Europa Forum Manual enters into force immediately after the adjournment of the Klagenfurt Europa Forum, with the exception of articles 5.2.2 and 5.2.3 of the By-Laws, where the entering into force will be at the adjournment of the Europa Forum in 2027 (as both the Archivist & Advisor and the EF Accountant were elected for 5 years in EF Zagreb in 2022).
